ORDINANCE NUMBER 754

RESTRUCTURING THE SALARIES FOR THE MAYOR; PRESIDENT OF COUNCIL; MEMBERS OF COUNCIL; CLERK OF COUNCIL; SOLICITOR ; AND ZONING INSPECTOR WITH SAID CHANGES TO BECOME EFFECTIVE JANUARY 1, 2008 OR , IN THE CASE OF ELECTED OFFICIALS, ON DATE OF THE INDIVIDUAL'S TAKING OFFICE UNDER NEW TERM.

WHEREAS, the Village Council has investigated into the salaries of Village officials throughout northwest Ohio and has conducted a survey to ascertain the range of salaries for comparable positions in similar villages; and

WHEREAS, Council has determined that after such investigation that the salaries presently being paid for those positions should be revised in order to provide fair and equitable compensation for its officials; and,

WHEREAS, Council has considered the salary ranges and duties of other villages and the present salaries and the experience and qualifications of the present officials and have determined that the salaries should be increased.

IT IS THEREFORE ORDAINED THAT THE salaries of the following officials of the Village of Van Buren shall become as set forth below:

Mayor:	\$2,400.00 per year
President of Council:	\$800.00 per year
Council Member:	\$50.00 per month
Clerk of Council:	\$4,200.00 per year
Solicitor:	\$4,000.00 per year
Zoning Inspector:	\$3,200.00 per year

It is further Ordained that the effective date of the new salary level shall be effective on January 1, 2008 for the appointed positions of Solicitor and Zoning

Inspector. For the elected officials the new salary levels shall become effective on the first day of the new term for that official. The new salary for the President of Council shall also become effective in the first day of the new term.

This Ordinance shall be effective from the third and final reading of this Ordinance and its passage by Counsel

BE IT FURTHER RESOLVED that it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


